- **Sense of Humor:** This should be a time when you **enjoy** learning about yourself and the possibilities for your future. If this process becomes dreary and stressful, something is wrong!

FAFSA

ALL SENIORS in Louisiana public high schools will be required to SUBMIT THE FAFSA OR APPLY FOR A WAIVER IN ORDER TO GRADUATE. See page 34 for details.

LEAP 2025

Seniors who entered high school in 2010-2011 and beyond are required to take the LEAP 2025 tests for graduation purposes. Students must score APPROACHING BASIC on LEAP 2025 tests in the following three groups: Algebra I or Geometry, English I or English II, and Biology or U.S. History. This requirement is in addition to the required number of Carnegie Units. Students have numerous opportunities to retake any LEAP 2025 not passed. Remediation is available to students who do not pass LEAP 2025 tests in accordance with St. Tammany Parish Pupil Progression Plan.

FHS HONOR GRADUATE

In order to graduate from Fontainebleau High with honors you must have a cumulative grade point average ranging between 3.5 and 3.999. Seniors with a 4.0 and above at the completion of the senior year will graduate with Top Honors. This is based on a weighted GPA. Honor graduates will receive a white cord to wear during graduation, and Top Honor graduates will receive a gold cord.

FHS RANK IN CLASS POLICY

Rank in class is determined upon graduation and is based on the quality points a student completes in grades 9-12. Although a full time student may complete more than 28 credits, only 28 credits will be applied toward a student's rank in class. Rank in class is determined based upon a student's best 28 credits completed in grades 9-12 AND a student's best 16 weighted courses from the designated course list completed in grades 9-12. Consequently, the student who earns the most quality points will be ranked number one in the graduating class. Per St. Tammany Parish School Board Policy, rank in class is not official or released until after graduation. Please see Ms. Francis if you require this information for college admission or scholarship consideration. An **approximate percentage** of your rank will be provided.

COLLEGE VISITS

Each senior is granted two excused absences for college visits. The student must provide verification of attendance from the college/university on official letterhead upon returning to school to Student Services. **College visits are counted as field trips.**

SECTION III: POST SECONDARY OPTIONS

“What do I want to do after I graduate from high school?” Will you continue your education beyond high school by attending a four-year college, a community, or technical college or perhaps join the military? These are questions you will have to think about and plan for before leaving high school.

THE COLLEGE SEARCH PROCESS

Before beginning the college search, it is important to realize that there is no “one and only perfect college.” A student’s needs may be met by a number of colleges. If you are applying to several schools, it is a good idea to include a “safety” and “probable” school as well as your “dream” school.

In choosing a college, the first things you will probably consider will be the type of academic program and the availability of the major you are considering pursuing. Listed below are some other things to consider when comparing colleges. How you rank these other factors will depend on your personal preferences and needs.

THE CAMPUS VISIT

A visit to the college or university is necessary to determine if the school meets your needs and future goals. **The campus visit is probably the most important step in helping you decide which college to attend.** Here are some tips to arrange the campus visit.

- CALL the Admissions Office 3-4 weeks in advance to request a campus visit.
- Have a particular DATE and TIME in mind, but be flexible.
- Plan to meet with an admissions staff member and take a tour of the campus. You may want to schedule your interview before the tour while you are still fresh. Some colleges require a formal interview, but most do not.
- Weekday visits are preferable to weekend visits, especially if you want to speak with professors or sit in on classes.
- If you plan to stay overnight, you may want to request a listing of hotels/motels and restaurants in the area. Ask for a campus map so you will know where you are going!!
- When calling to schedule your visit and appointments write down the name of the person SCHEDULING your appointment and the name of the person CONDUCTING your interview.
- Ask for written confirmation of your appointments.
- Remember to obtain verification of attendance on college/university letterhead in order to count as an official College Visit Day for senior exemptions.
- Colleges sponsor Open Houses, Visitation Days, Football Weekends, etc., which are excellent opportunities to learn and explore.

DO YOUR HOMEWORK prior to the campus visit. Read the college brochures and note any questions you may want to ask. Avoid questions that are already answered in the viewbook or printed materials. Take notes shortly after you leave in order to remember key impressions. You may wish to take your camera to add a few photos to aid in your recollections.

- Bookstore...is it well stocked and easily accessible?
- Counseling and Health facilities...available and adequate?
- Career Services...evidence of job postings and interviewers on campus?
- Information and Ride boards...variety of activities going on?
- Dining halls...? Mostly good reports from students? Try the food for yourself, if possible!

Read the campus newspaper to see what issues are important to the students. Read the bulletin boards. Approach students randomly and ask why they chose this particular college and how they like the college now. Do you feel comfortable on campus and think you would be happy to call it home for 4 years?

DECISION PLANS AND DEADLINES

Seniors need to consider multiple deadlines when applying to colleges. All schools have different deadlines. Students should check the deadline and notification dates for each school to which they are applying since these can vary. **Please make sure you check the college(s) deadlines for admission, financial aid and scholarships.** Many colleges have priority scholarship deadlines which means you must apply for admission to the school by that date to be considered for scholarships.

Early Decision (Binding)

This admissions decision requires that you commit to a college at the time of application. If you are accepted, you are required to enroll and withdraw all other applications. Consider the cost of the school and your financial situation before applying Early Decision. You should apply Early Decision only if you are certain that this is the school for you. You may only apply Early Decision to one school.

Restrictive Early Action (Non binding)

This admissions decision is non-binding, but students may only apply to one private school REA. They can usually apply Early Action to public schools, however.

Early Action (Non binding)

This admissions decision permits you to apply to a college and receive your admissions decision early during your senior year. You are not committed to attend the college and you may apply to other schools.

Regular Decision

The majority of applicants apply regular decision and the deadlines will vary from institution to institution.

Rolling Admission

Institutions review applications as they are submitted and render decisions throughout the admission cycle. There is no one set deadline for submitting an application. Applications continue to be submitted as long as there is space available.

THE COLLEGE APPLICATION PROCESS

1. **The Application**: The single most important step in completing a college admission application is also the simplest: read the instructions before filling out the form. Colleges expect you to read and follow directions; accomplishing this can set the stage for a favorable decision.

Some schools provide their own web-based applications. Others use one of the following services: Common Application (www.commonapp.org) or the Coalition Application (www.coalitionforcollegeaccess.org). See the website for a list of the partner schools. This service allows students to fill out one application online and submit the materials to multiple colleges.

2. **Application Fee**: Application fees range from \$25-80. This is a non-refundable fee. **If you qualify for free/reduced lunch please see Ms. Jackson about a waiver.**
3. **Test Scores**: Test scores are only official when sent through ACT. **It is YOUR responsibility to request that ACT send your test scores to the college(s).** If you do not have an ACT account, you will need to create an account at the following website: <https://my.act.org>. Once you have an account you will sign in and click on send scores which will walk you through the process. ****Many colleges are still test optional. Please check with individual colleges to determine if they are using test optional for admissions, scholarships or both.**
4. **High School Transcript**: The method used to send your transcript will be determined by the college and type of application used. Louisiana public schools can retrieve your transcript from the state system. Private and out of state schools who do not use one of the services below or provide an electronic upload service will require the high school to mail your transcript.
 - Common Application – electronically
 - Coalition Application - electronically
 - SENDedu (secure transfer system) – electronically
4. **High School Transcript Request Form**: **USE THIS FORM IF AND ONLY IF YOUR TRANSCRIPT MUST BE MAILED TO THE COLLEGE OR UNIVERSITY.** You will complete a “transcript request form” in the counseling office. After completing the form you will pay Ms. Fox, the school counseling secretary. It will cost you \$1.00 for the first copy, .25 for each additional copy, and an additional .75 to mail each copy. Ms. Fox will mail your transcripts. It takes Ms. Fox one week to process and mail your transcripts. Please plan ahead!
5. **Essay** - Many colleges require essays as part of the application. Think of the essay as a vehicle for conveying your “personal factor” to the college. Your writing must reveal your true personality, whatever that may be. Show us who you are and what you will bring to our program. Show us the contribution that only *you* can make.

6. **Letters of Recommendation and FERPA** – *Should you waive your right to see a recommendation letter? Why is this important?* FERPA (The Family Educational Rights and Privacy Act) is a federal law that protects the privacy of student education records. FERPA gives you the right to have access to your records after you enroll at a college unless you voluntarily waive your access to certain parts of that record. **Admission offices recommend that you waive your access to counselor and teacher recommendations. There is an expectation of confidentiality between your teachers and counselors and the admission office. If you do not waive access, colleges will wonder if the recommender was cautious in writing.** Often the strongest letters are actually those that include some insight into a student's weaknesses as well as strengths. Waiving your right gives the letter an extra measure of weight in the eyes of the admissions officer who reads it. **SEE PROCEDURE FOR REQUESTING LETTERS OF RECOMMENDATION ON PAGE 19.**
7. **Apply for Financial Aid** – **Beginning October 1** you can complete and submit the FAFSA form. . **COMPLETION OF THE FAFSA** (Free Application for Federal Student Aid) **IS A GRADUATION REQUIREMENT.** The FAFSA form is used to determine eligibility for federal and state aid based on need. The 2022-23 FAFSA Completion Guide and Workbook will be posted on the FHS website as well as Class of 2023 Google Classroom. We will announce the FAFSA Presentation as soon as we have a date. **Please see page 34 for specific directions.**
8. **Apply for Scholarships** - The best and largest source of scholarship money is still the university. **You apply for an academic/merit scholarship through the individual universities.** Louisiana public universities use their application for admission as their scholarship application. Many private/selective/out of state universities require a separate scholarship application. **Please check with individual colleges/universities for specific information.**
9. **College Transcript for Dual Enrollment Courses:** Seniors enrolled in a DE course through Southeastern Louisiana University and/or Northshore Technical Community college must complete a request through the college/university to have the college transcript mailed to the college they plan to attend in the fall. **This task is not completed until the end of the year when you complete your DE course.** (See senior handbook for details)

DUALLY ENROLLED SENIORS – REQUESTING TRANSCRIPTS

Seniors, it is **IMPERATIVE** that you request your college transcript be sent to the university you plan to attend in the fall. FHS cannot do this for you. You will not be allowed to enroll in the fall if the university does not have this information on file. Instructions are provided below for requesting your college transcript from **Southeastern Louisiana University, Northshore Technical Community College, Nunez Community College and the University of New Orleans.**

LETTERS OF RECOMMENDATION

Many colleges require letters of recommendation from your counselor and/or teachers. The colleges ask the counselor or teachers to comment on your academic performance, character, extracurricular activities, personal qualities and other information that may help clarify the student's application and set you apart from other students. **Some things to consider in requesting letters of recommendation:**

- Choose a teacher who knows you well and who will write a favorable letter for you. Ask the teacher if they would be willing to write a letter of recommendation for you. **Please make sure you make this request in person.**
- Give them a **minimum of 3-4 weeks or longer** to write your recommendation.
- Make sure to tell the teacher why you need this recommendation. Provide the teacher(s) with a copy of your resume' or the Personal Brag Sheet in the counseling office.
- Several days before the deadline, check with the teacher to be sure that it has been completed.
- Never ask for a copy of a teacher or counselor letter of recommendation.
- You should write the teacher a thank you note and inform them of any acceptances that involve schools to which they wrote letters of recommendation for you.
- It is your responsibility to keep up with your deadlines. **You should follow up with each university approximately two to three weeks after your deadline to verify the university has received all of your information.**

WRITING THE ESSAY (ADMISSION AND SCHOLARSHIP)

An important part of the college application is the essay or personal statement. Some colleges provide questions for students to answer while others leave it open-ended. For some colleges you may have to write more than one essay. It is our policy to recommend that you write an essay even if the college considers it optional. If a college does not have an essay for admission, it may have one for scholarship applications. Most outside scholarship applications also request essays.

Colleges and scholarship committees ask for an essay because it allows them to hear your voice and understand you as an individual, apart from test scores, grades, and activity sheets. The application essay or personal statement is the only guide admissions officers have of a student's personality. However, while students might spend weeks or months preparing for ACT, the average student spends only two hours writing the application essay.

Most students applying to selective schools will have similar grades and test scores. The primary way admissions officers choose among thousands of similar applicants is by evaluating their admissions essays.

What the Admissions Committee Seeks

In a tumultuous world economy, getting into an Ivy League school is more competitive than ever. Each year, Harvard, Yale and other Ivy League programs receive thousands of applications from candidates who have exceptional grades and SAT scores. How can you possibly distinguish yourself in such a formidable applicant pool? Write an impressive and unforgettable set of essays.

In our admissions work, we frequently see well-intentioned essays fall flat because they do not capture the reader's interest and convey the writer's true personality. Far too often, the essays simply reiterate material that is presented elsewhere in the application, which wastes a golden opportunity to present a new side of you.

Do not underestimate the committee's interest in your maturity and interpersonal strengths (or lack of them). Due to the high ethical standards and level of critical thinking expected in the Ivy League, your character and motivation will be highly scrutinized during the admission process. Use the essay set to sell your whole self, not just the individual pieces that you think they want to see.

Writing Tips

*In a typical day, an admissions officer will read between 25 and 50 application essays from candidates around the world. What stands out and makes a positive impression? Contrary to popular opinion, it's not simply academic prowess. Indeed, many candidates with exceptional grades are rejected each year. **For most competitive applicants, the key to admissions success is selling your unique (non-academic) strengths.***

Before you write, consider your audience and their objective. Committee members are vibrant people with unique personalities and talents. Their goal is to select a class of diverse, passionate students who will best contribute to the class. The ultimate class roster will include talented athletes, musicians, scientists and poets. No two successful candidates are alike, nor are their essays. A "great essay" can be about football, a dance recital, a family vacation or an embarrassing moment. What is the common denominator? Your writing must reveal your true personality, whatever that may be. Show us who you are and what you will bring to our program. Show us the contribution that only you can make.

Are there specific guidelines to follow? Absolutely! We surveyed thirty admission officers on what they expect to see in college application essays. Here is what works:

- *Answer the question that was asked.*
- *Write naturally, but concisely.*
- *Use excellent grammar and punctuation.*
- *Show your real personality (let us get to know you).*
- *Personalize your essay as much as possible.*
- *Use humor only if it works.*
- *Convey a positive message (avoid cynicism).*
- *Write about topics you are passionate about.*
- *Use the active voice.*
- *Explain events whenever appropriate*
- *Be specific and focused.*
- *Proofread several times and get feedback from valued sources.*
- *Revise and polish until it is perfect.*

For more information, giving examples on the above guidelines read the entire article.

THE INTERVIEW

Some colleges require or suggest a formal campus interview. Generally this is a time to share information and have questions answered. Arrive on time or a few minutes early. Dress neatly, attractively, and SMILE! Speak clearly and look at the interviewer. Be yourself...be honest, sincere, and interested. Be prepared to discuss your academic profile: GPA, ACT/SAT scores and curriculum. Be prepared to tell why you chose this school and what you hope to gain during your four years there. Refer to the "LIST" of questions to formulate your personal questions to ask. Here are some questions that students are often asked: Be prepared!!

- How did you first hear about our college?
- How familiar are you with this college and its programs?
- What accomplishments/activities have had a significant impact on your life?
- What are your academic strengths/weaknesses?
- What is the most significant contribution you have made to your school and/or community?
- What books or articles have made a lasting impression on your way of thinking?
- What might you be interested in as a future profession?
- What are your priorities in selecting a college?

QUESTIONS TO ASK A COLLEGE ADMISSION COUNSELOR!

- How many and what majors does this college offer?
- What is the teacher/pupil ratio?
- Are there special services for students with disabilities?
- What are the three most popular majors?
- What does the admission office consider when deciding to admit a student?
- Does the college have an athletic program?
- What division are your intercollegiate sports?
- Does the college have a health fitness center on campus?
- How competitive is the academic program?
- Does the college recognize AP courses and what is the policy for granting credit?
- Does the college recognize DE from SLU and what is the policy for granting credit?
- How many courses or credits are required for graduation?
- Is the college on the Quarter, Semester, or Trimester System?
- Do most students graduate in four years?
- How safe is the campus?
- What security policies are in place?
- What styles of residence halls/dorms are available for in-coming freshmen?
- Does the college provide housing for all four years?
- Does the college have an honors college?
- Do you have a co-operative education program or formalized internships available?
- What is the cost of attending including room, board, and tuition?

RESUME' OF HIGH SCHOOL ACTIVITIES

A high school résumé shows your achievements outside the classroom. Many college and scholarship applications require a résumé. There are many ways to organize and format your résumé. It is recommended that you include your résumé when you request a letter of recommendation. A sample is provided for you.

SECTION VI: COLLEGIATE ATHLETICS

NCAA - Steps to **NCAA** Eligibility Requirements

1. At the completion of your junior year or early in your senior year you must register with the NCAA Eligibility Center at the following website: www.eligibilitycenter.org
2. **You are responsible for submitting your official ACT/SAT scores to the NCAA Clearinghouse. The NCAA Eligibility Center Code is 9999.**
3. Ms. Francis will be notified by an email through NCAA to upload your transcript to the Eligibility Center website once you have completed registration.
4. **Academic Eligibility:** You must meet the NCAA academic requirements in order for the eligibility center to certify you to play college athletics. The requirements are different for the three divisions. Visit <http://www.ncaa.org/guide-college-bound-student-athlete> for more information. (Division 1 requirements below)

Division 1: Complete 16 core courses (on the NCAA approved FHS course list) and 10 of the 16 must be completed before the 7th semester (senior year) of high school. You must have a core-course G PA of at least a 2.300 and earn the ACT/SAT score matching your core-course GPA on the Division 1 sliding scale.

NAIA

The NAIA is the National Association for Intercollegiate Athletics. It offers fewer sports and recruiting restrictions than the NCAA, but its level of play is similar to that of the NCAA Division II. There are close to 300 schools in the NAIA. Schools that are part of the NAIA tend to be smaller in campus size and student enrollment, making this division a good choice for students looking for a supportive environment both on and off the playing field.

FREQUENTLY ASKED QUESTION:

- **If a student has been certified by the NCAA Eligibility Center, would that student need to be certified by the NAIA Eligibility Center, too?**
 - Yes. Certification of NAIA eligibility is separate from NCAA certification – two different associations, two different sets of eligibility rules, two different certification processes.

NAIA Louisiana colleges include Dillard University, Louisiana State University (Alexandria and Shreveport), Loyola University, Southern University at New Orleans, Xavier University. For additional information, see (www.naia.cstv.com)

SECTION VII: FINANCIAL AID

Types of Financial Aid

Be sure you understand the differences between types of financial aid so you are fully prepared to apply for each. One or more of these financial resources may make it possible to pursue the education you want.

Grants

Financial aid, often based on financial need, which does not need to be repaid (unless, for example, you withdraw from school and owe a refund).

Scholarships

Scholarships, also called “merit aid,” are awarded for academic excellence. Repayment is not required.

Loans

Student loans, which have lower interest rates, may be college-sponsored or federally sponsored or may be available through commercial financial institutions. Loans must be repaid with interest, generally after you have graduated or left school.

College Work-Study

College work-study is a federally sponsored program that enables colleges to hire students for employment. If eligible, students work a limited number of hours throughout the school year. Many private colleges offer forms of “self-help employment” aid as their own supplement to the diminishing supply of federally funded work-study.

Louisiana Rehabilitation Services

Vocational Rehabilitation (VR) is a program that provides services to help persons with disabilities obtain the job skills and other resources they need to get a job, keep a job, and develop a career. VR assists persons with a broad range of disabilities. For more information, please call (504) 838-5180.

Academic Common Market

The Academic Common Market is a tuition savings program especially for college students who live in the 16 states that are members of the Southern Regional Education Board (SREB). If you live in an SREB state, you may be able to enroll in an eligible degree program offered in another SREB state – but pay in-state tuition rates. For more information visit www.sreb.org/acm.asp.

HOW DO I APPLY FOR FINANCIAL AID?

****BEGINNING WITH THE 2017-18 SCHOOL YEAR, ALL SENIORS ARE REQUIRED TO COMPLETE AND FILE THE FAFSA AS PART OF LOUISIANA GRADUATION REQUIREMENTS.**

Follow the 5 steps below:

1. Apply for admission to college.
2. You and one parent will each need to create your own FSA ID at www.FSAID.ed.gov.
3. On or after **October 1, 2022**, you can complete and submit the Free Application for Federal Student Aid (FAFSA) at www.fafsa.gov using your 2021 Federal Tax Return. It is recommended you use the IRS Data Retrieval Tool.
4. After submitting your FAFSA you will receive a confirmation email. The email will read "Congratulations on submitting your FAFSA." **BRING A COPY OF THIS EMAIL TO MS. FRANCIS. THIS SERVES AS VERIFICATION THAT YOU HAVE MET THIS GRADUATION REQUIREMENT.**
5. After submitting your FAFSA you will receive your Student Aid Report (SAR) within 3-5 days through the email you provided. **It is crucial that you review your SAR and make any corrections needed on the FAFSA.**

ADDITIONAL INFORMATION:

- The results of your FAFSA will be sent to the colleges/universities you listed on the FAFSA application. You can list up to 10 schools.
- Once you are accepted to the college, the admissions office provides you with information to set up an account. This is referred to as the student's portal. Check this account regularly for important messages from the college financial aid office.
- All male students are required to register with the Selective Service in order to receive any kind of financial aid, including TOPS! This is part of the FAFSA.
- Many four-year **private colleges require the CSS PROFILE in addition to the FAFSA.** The PROFILE is a need analysis report, not an aid application. Check with the individual university to determine if the CSS profile is required as well as the deadline for submission. The CSS PROFILE is available at: www.collegeboard.com
- It is important that you check your state and school deadlines so you do not miss out on any aid. State deadlines are on fafsa.gov and school deadlines are on the schools' websites.

SECTION VIII: SCHOLARSHIPS

GENERAL SCHOLARSHIP INFORMATION

(1) ACADEMIC/MERIT SCHOLARSHIPS:

The best and largest source of scholarship money is the university. You apply for an academic scholarship through the individual universities. Louisiana public universities use their application for admission as their scholarship application. Many private/selective/out of state universities require a separate scholarship application. Please check with the individual college/university for specific information. **Academic scholarships are based primarily on your core GPA and test scores.** The deadlines range from October 1 through February 1 depending on the university.

(2) LOCAL SCHOLARSHIPS:

We receive numerous scholarship applications throughout the year. As we receive the information, I will notify students via google classroom. You will also be notified through the morning announcements, your English IV teachers and email. A comprehensive list of all scholarships we receive through our office can be found in your senior handbook in the "Scholarship Chart." **IT IS YOUR RESPONSIBILITY TO KEEP UP WITH YOUR SCHOLARSHIP DEADLINES.**

TOPS SCHOLARSHIP PROGRAM

What is "TOPS"?

Louisiana's Taylor Opportunity Program for Students (TOPS) is a comprehensive program of state scholarships and one of the most innovative and progressive student assistance programs in the nation. TOPS has four award components including Opportunity Award, Performance Award, Honors Award, and Tech Award.

How Do I Qualify for the TOPS Scholarship?

Opportunity Award: 20 composite score on ACT
2.5 GPA in 19 core courses

Performance Award: 23 composite score on ACT
3.25 GPA in 19 core courses
Additional \$400/year

Honors Award: 27 composite score on ACT
3.5 GPA in 19 core courses
Additional \$800/year

Must meet the two-year residency requirement as determined by the LOSFA office.

How & When to Apply for TOPS?

The application used to apply for TOPS is the FAFSA. To apply for TOPS, you must complete the Free Application for Federal Student Aid (FAFSA) which is a graduation requirement in Louisiana. You may complete the On-Line Application for TOPS instead of the FAFSA ONLY if you meet the following two requirements. 1) TOPS is the only state program for which you are applying and 2) You do not qualify for Federal Grant Aid (Federal Pell Grant).

What is the Deadline to Achieve a Qualifying Score on the ACT/SAT?

You must achieve a qualifying score on or before the ACT national test date in April in the academic year you graduate from high school. Beginning with graduates of 2021, you may qualify on a test taken after the ACT national test date in April, but prior to August 1, by using May, June, and/or July test scores, including scores from a special ACT or SAT, **but your period of eligibility for the award will be reduced by one semester or two quarters.**

In very limited circumstances, the Board of Regents may grant an exception to the April deadline IF it determines that the applicant had registered for a test prior to August 1 but was prevented from taking the test prior to August 1 of the year of graduation due to circumstances beyond the immediate control of the student AND attributable to the administration of the test. If it makes this determination, a student will not be penalized one semester or two quarters. Scores earned on an ACT/SAT taken after August 1 but before September 30 immediately following high school graduation may be accepted on a very limited basis. The Board of Regents must grant an exception to the August 1 deadline because it determines that the applicant was prevented from taking the test prior to August 1 of the year of graduation due to circumstances beyond the immediate control of the student AND attributable to the administration of the test. Illnesses, lack of transportation, death in the family, and similar circumstances are not attributable to the administration of the test and will not support an exception to the ACT deadline.

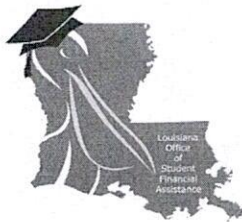

Beginning with students entering the 9th grade in 2014-2015 and graduating in the 2017-2018 school year and thereafter, the calculation of the TOPS Core Curriculum grade point average (GPA) will use a five- (5.00) point scale for grades earned in certain designated Advanced Placement (AP) courses; International Baccalaureate (IB) courses; Gifted courses; Dual Enrollment courses, Honors courses and Articulated courses offered for college credit by the Louisiana School for the Math, Science and the Arts used to complete the TOPS Core Curriculum. For the designated courses, five quality points will be assigned to a letter grade of "A", four quality points will be assigned to a letter grade of "B", three quality points will be assigned to a letter grade of "C", two quality points will be assigned to a letter grade of "D", and zero quality points will be assigned to a letter grade of "F". Note that students earning credit in courses graded on the five (5.00) point scale may earn a grade point average on the TOPS Core Curriculum that exceeds 4.00.

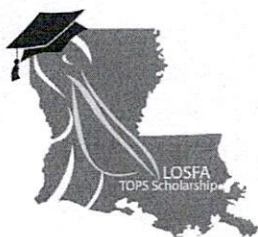

TOPS Awards are dependent upon an annual appropriation of funds for TOPS by the state legislature. Eligibility for a TOPS Award does not guarantee that your award will be fully funded.

You have established your eligibility for a TOPS Award. To receive the award:

- You must enroll for the first time as a full-time student at an eligible institution NO LATER THAN the first regular semester or quarter that is one year after your high school graduation. (If you graduated in May 2021, you must enroll no later than the fall semester or quarter of 2022). If you choose to first enroll in an eligible out-of-state institution, and do so by the first semester following the first anniversary of your high school graduation, you may transfer to an eligible Louisiana school and reinstate your award PROVIDED that you have met all requirements for renewal of the award. You will lose one semester (quarter) of eligibility for each semester (quarter) you were enrolled in an out-of-state institution. You must apply for a TOPS Award by submitting an *Application to Return from an Out-of-State College* no later than July 1 immediately following the fall, winter or spring semester or quarter that you transfer to an eligible Louisiana school or within 120 days after that July 1 for a reduced award. The supporting documentation must be received no later than January 15 of the following year. You can download the application at <https://mylosfa.la.gov/wp-content/uploads/2021/04/ROOS-Application.pdf>.
- If your application or the required documentation is not received by the applicable deadline, it will **NOT** be considered and you will **NOT** be eligible to receive a TOPS Award.
- If you enlisted and began serving on active duty in the United States Armed Services within one year of the date you graduated from high school and before you enrolled in college as a full-time student, you are allowed to defer your enrollment at an eligible institution for the period of time you are continuously on active duty, including reenlistments, and until the first regular semester following the one year anniversary of your separation from active duty. You must provide a copy of your DD Form 214 "Certificate of Release or Discharge from Active Duty" before you will be eligible for your TOPS Award.

To retain your TOPS eligibility, you must be registered **each semester or quarter as a full-time student** as of the 15th class day at a semester institution or the 10th class day at a quarter institution and remain continuously enrolled. Correspondence courses do not count toward full-time enrollment.

Your TOPS Award may be combined with other financial aid (scholarships, grants or loans) but if your total financial aid package exceeds the cost of attendance established by your institution, your TOPS Award amount may be reduced. If other aid exceeds your cost of attendance and your TOPS payment is zero, that semester will **not** be counted toward your 8 semesters (or 12 quarters) of TOPS eligibility. Contact the financial aid office at the institution you are attending for an explanation of how your award may be affected by other aid.

AWARD DURATION:

- You may receive a TOPS Award for a maximum of 8 semesters or 12 quarters. (Summer sessions in academic programs will be paid only under specific conditions and only if funding is sufficient. Intersessions will not be paid. Check with the financial aid office at your school to learn whether your award can be paid for a summer session. If you use your TOPS Award to pay for a summer session, it will count as one of your 8 semesters or 12 quarters of eligibility.)
- Out-of-state transfer students' eligibility will be reduced by the number of semesters or quarters attended at the eligible out-of-state institution.
- If you have semesters/quarters of eligibility remaining once you complete your first undergraduate degree, you may use any remaining semesters/quarters for **postgraduate study**, provided you enroll in a graduate/professional school no later than the fall semester/quarter following the one year anniversary of completion of your undergraduate degree. You **CANNOT** use remaining semesters/quarters of eligibility to pursue a second undergraduate degree.
- If you complete a non-academic (technical) program of study, you may use remaining semesters/quarters of eligibility to enroll in another technical program or to enroll in an academic program.

PROPRIETARY AND COSMETOLOGY SCHOOLS

- To be eligible to receive your TOPS Award, you must be enrolled full-time according to your school on one of the following dates: September 1, December 1, and March 1. (Note: If the 1st falls on a weekend or holiday, you must be enrolled and attending classes prior to that weekend or holiday for your award to be paid for that term).
- To maintain your award, you must meet federal grant aid requirements for steady academic progress at your school.

PRIVACY INFORMATION: If you are either 18 years old or are actually attending college, the federal Family Educational Rights and Privacy Act (FERPA) does not allow disclosure of your personal information to anyone, including your parents or custodian, unless you grant them access to your records. TO RENEW YOUR AWARD

- If you must resign from all classes during the semester or quarter (or if you transfer to another college after the semester or quarter has begun), you should officially resign with the Registrar's Office so that you do not receive failing grades in all of the courses in which you were enrolled. If you do not, your TOPS Award may be suspended or canceled.

STEADY ACADEMIC PROGRESS and CUMULATIVE GRADE POINT AVERAGE REQUIREMENTS:

- You must make Steady Academic Progress (SAP) (earn a cumulative GPA of at least 2.00 on a 4.00 scale) at the end of **every** semester/quarter/session for which grades are reported. If you do not earn at least a 2.00, your award will be suspended since you did not make SAP.
- In addition, you must meet the minimum required TOPS Cumulative Grade Point Average (TOPS Cum GPA) for your award at the end of each summer semester or quarter to maintain your award. Depending on the hours completed, you must maintain the following TOPS Cum GPA:

NOTE: Your TOPS Cum GPA is calculated on all college coursework you attempted at all schools, including dual enrollment and repeated courses. It is based on hours, grades, and quality points reported by all schools you have attended, so it may be different from the grade point average calculated by the school you attend. Repeat-delete and +/- grades do not apply for calculation of your TOPS Cum GPA.

- If you have been awarded the TOPS Performance or Honors award and you have earned at least 24 hours with a TOPS Cum GPA of less than a 3.00 Cum GPA at the end of any **summer semester or quarter**, your award will be permanently changed to the Opportunity award for the remaining period of eligibility and you will not receive the stipend that goes with the award. **Once a stipend is lost, it cannot be regained. There are no exceptions.**
